Head of School Report

Review of Opportunity Youth

- Opportunity Youth will be defined as those students that are severely off-track to graduate with their four-year accountability cohort based on a minimum population threshold of 620%. More specifically, at lease 60% of students must be two or more years off-track to graduate in four years (upon enrollment) and exhibit at least two of the characteristics listed.
- Has been involved in the criminal justice system
- Has failed at least one course during their middle school
- Has been dis-enrolled from high school for at least one semester
- Is parenting
- Is in or nearly aged-out of foster care
- Has a long-term history of housing insecurity or mobility
- Has documented physical health challenges
- Has an Individual Education Program
- Has documented mental health challenges
- Exhibits Post Traumatic Stress Disorder tendencies due to childhood trauma

Opportunity Youth Measures

- The Center has identified one standardized academic measure and will collaborate with partner schools to identity two-standardized measures that reflect the specific mission of the school and help to tell the school's story. The standardized academic measure is improvement in grade level performance on NWEA MAP
- Distribution of students who improved at least one grade level from pre-test scaled scores (which will be in the form of percentages):
- Meet ≥ 50.0%

- Board Policy Updates
 - 0100-Definitions. Revision of current policy. Legally required. The definition of "Voting" has been revised to reflect the change in statute regarding allowable exceptions to "in person" voting at meetings of the Board, only the military duty exception remains.
 - 0167.3 Public Participation in Board Meetings. Revision of current policy. Legally required and in line with recent U.S. District Court of the 6th circuit.
 - 0167.3 optional language deleted. To remove the authority of the presiding officer at board meetings where public participation is permitted to regulate speakers based on comments that are "above," "frivolous," and/or "harassing." These measures are intended to prevent academies from engaging in viewpoint in nature, perceived as hostile to the direction of the board and/or merely offensive, Options have been added for preregistration, including prohibiting individual in nature, perceived as hostile to the direction of the board and/or merely offensive, Options have been added for preregistration, including prohibiting individuals from signing up to speak for others.



Finally, there are options for academies who livestream meetings to determine whether they will facilitate public participation remotely.

- 6114 Cost Principles Spending Federal Funds. Revision of current policy and legally required. Updates provide greater detail in allowability guidance for academies regarding expenditure of federal funds.
- 7450 Property inventory. Revision of current policy and legally required. A drafting note has been added to this policy noting the federal threshold of \$5,000 for differentiating between supplies/materials and a capital expenditure for equipment purchase.
- 8310 Public Records Revision of current policy and legally required. This policy has been revised to comply with the obligation not to disclose the address of a student or an employee who provides the Academy with notice that they received a participation card issued by the attorney general under the Address Confidentiality Program Act. The address confidentiality program; to provide certain protections for victims of domestic violence, sexual assault, stalking, or human trafficking and for certain other individuals
- 8330 Student Records Revision of current policy and legally required. Revised to reflect change in federal rule. If the Academy issues student email addresses, it must release such email addresses to military recruiters as part of directory information, as requested, unless prohibited by student or parent request in writing.
